## **Recertification requirements**

#### YOUR RECERTIFICATION CANNOT BE PROCESSED WITHOUT THE FOLLOWING ITEMS:

- 2-Page form enclosed in recert envelope **MUST** be filled out in black ink.
- Your last 6 months of bank statements for every adult in the household. <u>This includes non-conventional</u> <u>accounts such as Chime, Paypal, DirectExpress,</u> <u>GreenLight, ApplePay, etc</u>. (the most recent ones closest to the date of your appointment)
- If you are employed You MUST bring your last 4 paystubs
- Complete the Self Certification of Assets under \$5000.00, If over \$5000.00 please provide documentation.

## ALL ADULTS (18 YEARS AND OLDER) MUST ATTEND THIS APPOINTMENT.

You are welcome to use our computer to print the items if you need to. If you decide to do <u>this please come in earlier then</u> your scheduled appointment to allow time to print these items.

# Exciting news...

#### REMINDERS ABOUT GARBAGE AND RECYCLING

All trash must be placed in bags and put in supplied trash cans. You cannot put out extra bags as the city will not pick them up. It also allows raccoons and other animals to get into these bags and scatter trash in the yards.

Blue recycle bins should only have the following in them, or the city will not pick them up and you will have your recycle bin removed. If you would like to know what is permitted to be in these bins, please see the attached flyer provided by the city.

Failure to follow the above rules can result in extra fees charged to your account.

## NOTICES...

If HHA needs to enter your unit for a repair, inspection, spray, etc and you have been given proper notice, residents must allow entry. There have been instances of residents being inside their unit and locking the storm door so entry cannot be made. This is not allowed. As stated in the House Rules attached to your lease under MAINTENANCE AND WORK ORDERS "Failure to allow entry into the unit for an inspection or scheduled work for which residents have been given proper notice is a serious violation." A 30 day notice of lease termination can be issued.

# SMOKING...

Please remember if you are smoking in your unit, or not smoking 25 feet from an HHA building, this is not allowed, as stated in the House Rules attached to your lease. This is a lease violation and a 30 day notice of lease termination can be issued.
